1. Welcome and Introductions

The Chair welcomed attendees to the meeting.

2. Apologies for absence

3. To confirm and agree minutes of the meeting 24TH May 2016

6. Report on Rectory Farm workshops

SL and RS reported on the Workshop

There had been one Workshop since the last Steering Group meeting and this comprised a walk around the proposed site. Four Steering Group members and one local resident accompanied the Agent and Stefan Kruczkowski (SK) around the site.

The walk started near Little Jacks and followed the former railway track bed behind Bowbridge Gardens. Discussion occurred on the positioning of the access road and it was proposed that it would be on the western side of the band of trees and scrub which separated the pathway (trackbed) from Little Jacks Farm. This would attenuate any traffic noise arising from the access road. The deep bed of nettles was seen to provide an element of security for the rear of the Bowbridge Gardens properties. As we continued along the path we considered the field to the north of the Devon. SK suggested that the properties backing onto the southern side of Bowbridge Gardens should reflect the pattern of existing housing in that area and that an arrangement garden to garden would again provide security and maximize the spacing between existing and any new houses. The local resident mentioned the flooding that occurred in that area which affected the gardens of the Bowbridge Gardens properties. This was seen to be surface water rather than originating from the Devon and could be resolved as part of the development. A number of buildings in the Rectory Farm could be considered for

development and overall the extent of the site was seen to be capable of producing several distinct character areas.

Continuing down the path we came to the area where the access road would cross the pathway and then follow the eastern arm of the former railway triangle and utilize the bridge over the Devon. It was thought that this may not be wide enough for two lanes of traffic plus footways but that some directional priority would be an advantage in reducing traffic speed. Shortly after crossing the bridge the road would turn east and drop onto the main area of the site and consideration was given as to how the views of St Mary's Church could be protected and enhanced. We skirted the field behind the fence until we reached the occupation crossing where the Sustrans route would pass on the way to Kilvington.

We then crossed the Field towards Devon Farm further considering the church views, potential character areas, secondary limited access onto Normanton Lane and how the existing hedges and trees could best be utilized along with the possibility of advance planting.

In this area there is a tree screen which cuts off some of the views of the Riverside Walk and Riverside Close properties. This screen would be enhanced by the creation of a linear park on the north side of the Devon.

Throughout the walk SK was sketching and making notes to take back and produce an outline scheme.

The Chair suggested that a similar arrangement of a site visit could be put to Herbert and Andrew Daybell to include local residents and V C Hall representatives. BB to ask Colin Wilkinson if he minds Herbert and Andrew Daybell attending the next Workshop.

There was also a need for a car park by the Chapel and this had been mentioned on the site visit. The Chair wondered if the Agent had spoken further to the owners of Perfectos Inks and the Creamery over the future of the land and second access to the Rectory Farm area. It was thought that development of the SHLAA site behind the tip would not now proceed, certainly in the short term.

7. Development Updates

A report had been submitted to the Parish Council regarding the SHLAA sites in Easthorpe MBC/026/16, MBC/027/16, MBC/028/16. There is no further update.

8. Parish Council update.

The pre submission Neighbourhood Plan draft is to go to the Parish Council Clerk in time for the brought forward PC meeting on the 4th July. This document would be the opportunity for the residents of the Parish to comment on the proposals.

9. Writing the Bottesford Neighbourhood Plan

RS reported that the group continues to meet 2-3 times a week for 3-4 hours and good progress had been made with the Plan. About 60 pages had been drafted out and to a great extent now reflects the final text.

The group were asked whether they were getting enough assistance from MBC and did we need external planning help. External help was not required to date.

It was announced that Rachel Armstrong was leaving MBC and it was agreed that Rachel had been of substantial assistance in the short time we had known her and her departure would be a great loss. RS was asked to send a letter of thanks for her help.

RS said the intention was to issue the pre submission Neighbourhood Plan to all households in the Parish in September when most of the absences due to summer holidays would be over.

The Market Bosworth NP was very professional and John Preston had provided the name of the compiler. BB to write to him regarding specification and cost of setting up our NP.

CL asked about NP returns all being provided with the returnees name and address, it was confirmed that this would be the case and that those returning comments digitally would also be required to provide this information. It was also confirmed that the Pre submission Neighbourhood Plan would not be in colour except on pages where it was necessary for clarity.
